# King and Queen of the Latrine Contestant Eligibility Criteria

Contestants must meet the following criteria in order to participate in the 2020 King and Queen of the Latrine pageant.

#### All Contestants:

- 1. Contestant must be at least 21 years of age. Proof of age is required by a valid government issued Photo ID, no photo copies will be accepted.
- 2. Contestant must be available to perform all required duties throughout the year as described under Title Holders Obligations and Responsibilities.
  - 3. Contestant must pay a registration fee of \$50.
- 4. **ONLY** the **first 5 King and 5 Queen** contestants with Registration **PACKETS AND FEES** turned in will be accepted. Registration opens on Friday January 24th, 2020 and will remain open until all spots are filled, or the day before the pageant.
- 5. All Packets and Fees being turned in must be turned into The General Manager of Gregs Our Place to be counted as tuned in, if you hand it in to anyone else, and the 5 spots are filled before given to the General Manager, it will not be accepted.

# **King and Queen of the Latrine Pageant Rules and Regulations**

The following rules and regulations will apply for the 2020 King and Queen of the Latrine Pageant

# 1. Judging

- 1. Judging will be done by our selected judges panel that will be announced at the beginning of the contest on February 29th, 2020.
- Judges will be using a provided judging sheet utilizing a point based system with a maximum allocated points per category.
- 3. General Manager of Gregs Our Place has final say on the judging panel and judging criteria.
- 4. Each contestant will have their lowest score dropped. In case of a tie, the scores will be added back in to break the tie.
  - 1. If there is a second tie, then the General manager, and bartenders working along with the show DJ will do a blind vote for the winner.
- 5. There will be an auditor onsite to do the official tally of points, and votes if needed.

2. Categories: all contestants will be judged in the following categories.

#### 1. Presentation-

- 1. This category requires attire based on The Theme: "The Toilet Bar"
  - 1. Gregs Our Place was referred to as the "Toilet Bar" in the 1980's and into the 1990's. This is the reason for the Toilet Our Place sign hanging above the show room doors.
- 2. We are looking for the best representation of the theme, authentic to campy, after all we enjoy a good laugh as much as a good time.
- 3. The theme and criteria is determined by the General Manager with the help of the show DJ.
- 4. Show DJ will provide music for this category, unless contestant wishes to bring a specific track to go with their attire.
- 5. Presentation will take no longer than two minutes.
- 6. Contestant Bio will be read during this time.
- 7. Sponsors are allowed and can be announced during this category.

### 2. Onstage Question and Answer

- 1. This category will consist of two questions, one to take place before the contestant leaves the stage after Their presentation and one after Evening Gown.
- 2. Each contestant will have a serious question, that will be centered around the history and or current topics associated with the LGBT community, Greg's Our Place, and our community.
- 3. Each question will have a more entertaining or funny question to answer with topics of anything the judges and bar staff come up with.

## 3. Evening Wear/Gown

- 1. Contestants will be judged in a full-length evening gown for Queen contestants and formal wear for King contestants.
- 2. it may be of any color, style, and fashion
- 3. Contestants will be judged on:
  - 1. Gown/Formal wear selection
  - 2. Fit
  - 3. Hair &Makeup
  - 4. Accessories
  - 5. Poise
  - 6. Modeling ability
  - 7. General Appearance

#### 4. Talent

- 1. Any type of talent is acceptable, except those that are illegal or which may cause personal injury to the audience or any other person.
- 2. Talent will be no longer than 8 minutes, and no more than two minutes will be allowed for prop setup with prop breakdown taking no longer than one minute.

- 3. All music must be on CD or USB, music not on CD or USB will not be accepted. CD or USB must only have two tracks on it. Track one being contestants talent, track two being a crowning number should they win.
- 4. Each contestant may have UP TO 5 dancers on stage with them.
- 3. The use of illegal substances is prohibited and is ground for immediate disqualification.
- 4. Theft of or intentional damage or destruction to any contestant's property, or theft of or intentional damager or destruction to any Greg's Our Place and Staff will be grounds for immediate disqualification and ejection from Greg's Our Place.
- 5. Contestants are required to conduct themselves in a professional manner at all times. Any violent or threatening language or behavior will not be tolerated and will be grounds for immediate disqualification and ejection from Greg's Our Place.
- 6. Each contestant will be allowed one dresser in the dressing room.
- 7. Any contestant that is not in an appointed place at the appointed time, can be disqualified.
- 8. The King and Queen of the Latrine Pageant is gender inclusive, it doesn't matter what gender you identify, you are welcome to compete.
- 9. Discrimination against any person on the basis of race, religion, color, sex, age, national or cultural origin, ancestry, marital status, parental status, gender identity, sexual orientation, disability or health status will not be tolerated.
- 10. Greg's Our Place Owners and General Manager reserve the right to make a decision concerning any matters not covered in these rules and regulations and/or the contestant agreement.

# **Contestant Media Release**

- 1. Contestant authorizes Greg's Our Place to use the following personal information as relates to the pageant/ contest:
  - 1. Their picture- including photographic, motion picture, and electronic (video\_ images
  - 2. Their voice- including sound and video recordings
- 2. Contestant herby grants Greg's Our Place and its subsidiaries the right to use, publish, reproduce, for all purposes, their name, picture of them in film or electronic form, sound and video recordings of their voice, and printed and electronic copy of the information described in All above sections, in any and all media including, without limitation, cable and broadcast television and the internet, and for exhibition, distribution, promotion, advertising, sale,

- press conferences, meetings, hearings, educational conferences and in brochures and other printed media.
- 3. Contestant further grants Greg's Our Place all rights, title, and interest that they may have in all finished pictures, negatives, reproductions, and copies of the original print, and further grants Greg's Our Place the right to give, sell, transfer and exhibit the print in copies or facsimiles thereof, for marketing, communications, or advertising purposes as it deems fit.

#### Title Holder's Obligations and Responsibilities

- 1. The winner(s) (hereafter, "Titleholder(s)") of the pageant will assume the title of King or Queen of the Latrine for the 2020 season and shall retain the title until the following pageant. Titleholder is obligated to and agrees to the following:
  - 1. Work with Greg's Our Place staff in planning titleholders step-down pageant in 2021.
  - 2. Titleholders agree to join Greg's Our Place on their float in the Indy Pride Parade.
  - 3. Both titleholders agree to participate in the 40th Birthday Celebration for Greg's Our Place to take place on July 11th 2020.
  - 4. Titleholders agree to participate, in some capacity (performing, dressing, or staffing the bar) for Bitches With Balls in September.
  - 5. Title holders agree to host/MC 3 additional events to be determined between the manager and titleholder.
  - 6. Title holder agrees to organize and run one fundraiser at Greg's Our Place.
  - 7. Titleholder agrees to host the Customer Appreciation party in December.
- 2. Titleholder agrees to hold the respective title, The King and Queen of the Latrine and Greg's Our Place brand in highest esteem. While appearing, entertaining, or otherwise representing the title of King and Queen of the Latrine or Greg's Our place during the reigning year, the Titleholder agrees the following:
  - 1. Not participate in malicious gossip.
  - 2. Not participate in social media "wars"
  - 3. Not undermine the mission, vision or values of Greg's Our Place.
- 3. Titleholder will provide a satisfactory publicity photograph with the Crown/ Sash within 15 days of assuming the title, for use by Greg's Our Place, Contestant Media Release shall apply, substituting Titleholder for Contestant in all cases.
- 4. Titleholder will maintain contact with Greg's Our Place Management during the year of reign.

# King and Queen of the Latrine Remedies

In the event Titleholder is unwilling or unable to fulfill their obligation and responsibilities outlined above, or if the Titleholder defaults on any of the provisions included in this contestant agreement, Greg's Our Place retains the right at its absolute and sole discretion to any or more of the following:

- 1. Revoke or rescind the title from the Titleholder
- 2. Pass the title to the 1st runner up from the pageant.
- 3. Refuse bookings and appearances of an official nature to the Titleholder.
- 4. Demand the return of all prize monies and/or any other awards given during the period under reign.
- 5. Refuse entry into any future pageants
- 6. Other remedies, not listed above.
